# RE: Update on the Grand Pré and Area Community Plan

The Grand Pré and Area Community Plan is a Municipal planning document intended to promote a common vision for the four communities of Grand Pré, Hortonville, North Grand Pré, and Lower Wolfville. As you are aware, the draft Grand Pré and Area Community Plan was taken out for public consultation in March. We held an open house on 11 March and then a more formal presentation with a question and answer period (public meeting) on 16 March. Both sessions were well attended.

**RE: Report on International Expert Workshop** 

#### **BACKGROUND**

International experts were invited to a workshop organised between the 14<sup>th</sup> and the 16<sup>th</sup> of April 2010. They were also invited to present at the symposium on agricultural heritage held on April 17<sup>th</sup> at Acadia University in Wolfville.

The purpose of the workshop was to review the information available that had been prepared up to this point for the nomination proposal and visit the site. This included:

- Draft outstanding universal value report (January 2009);
- Draft 2 Comparative analysis (March 2009)
- Draft 2 Management Plan (April 2009);
- Draft 2 Strategy for the management and conservation of archaeological heritage in Grand Pré;
- Tourism study:
- Landscape analysis (January 2010);
- Draft 1 Risk Preparedness;
- Key maps;

The outcome was a discussion about the value and the management and recommendations on improving them.

#### **EXPERTS**

The members of the workshop included:

- Susan Buggey, consultant, cultural landscapes World Heritage advisor (Canada);
- Christina Cameron, Professor, University of Montreal World Heritage advisor (Canada);
- Peter J. Fowler, Professor emeritus, Newcastle University World Heritage advisor (United Kingdom);
- Alexandra Kruse, consultant, Network coordinator, Eucaland World Heritage advisor (Germany);
- John Pinkerton, Manager, International Programs, Parks Canada (Canada)
- Edwin Raap, Project Manager, Cultural history (Netherlands);
- Herb Stovel, Professor, Carleton University World Heritage advisor (Canada);

Were also invited a number of local residents and stakeholders.

#### PRELIMINARY OUTCOME AND COMMENTS (IN NO PARTICULAR ORDER)

- Very strong positive comments on quality of information gathered and analysis;
- General direction of outstanding universal value is solid but requires additional work of the argument to clearly articulate the site's universal value;
- Comparative analysis is challenging and needs to focus on clearly comparing the criteria and articulating the connection between the different dimensions of the site (agricultural and memorial):
- Solid candidate for nomination:
- There has been much discussion about the boundaries, but the conclusion is that it is satisfactory;
- The argument for the buffer is compelling;
- The management plan needs to clearly reflect how the outstanding universal value and its attributes are managed, as well as articulate the mitigation measures for the pressures that were identified:
- Quality of the maps is high;
- Strong positive reviews of community engagement and awareness;
- Imperative to have a clear and solid governance structure with an integrated approach to protecting and promoting the site;

#### **FOLLOW UP**

The final comments are still being compiled by each expert. However, the priority for the project manager is to draft a revised statement of outstanding universal value and revised comparative analysis to have a convincing argument by the time a draft nomination proposal is ready in June. Drafts will be prepared and circulated to experts in order to have a strong justification for the Advisory Board to approve in July.

#### **GENERAL**

Focus is on completing a draft nomination by next Advisory Board meeting scheduled on July 8th. The international expert discussions and ongoing work has brought about extremely valuable direction. Challenges remain but the foundations are strong. A separate short report outlines the outcome of the international expert workshop.

## Highlights include:

- Revised statement of outstanding universal value is underway;
- Draft 3 of the comparative analysis is underway;
- Draft 3 of the management plan is underway;
- Draft nomination proposal is underway;
- Draft management plan for the national historic site has returned from Aboriginal consultation;
- Draft community plan is being prepared for consultation;
- Final draft archaeological heritage strategy is underway;
- Compilation of appendices is underway;
- Final draft coastal erosion study is underway;
- Draft Risk preparedness plan is underway;
- Map production is underway;
- Design of the nomination proposal is underway;

#### SPECIFIC COMPONENTS OF THE PROJECT AND OF THE PROPOSAL

# **Description of Area:**

Nothing to report.

Next steps: Draft section completed.

#### Justification for Inscription:

A revised statement of Outstanding Universal Value is being prepared based on feedback from international experts and the Canadian delegation. The essence of the proposal is not changing.

It is still about the dykelands, agriculture, the memorials and the landscape. The changes result from a need to make a much stronger and convincing argument based on comparable sites, on the criteria, on UNESCO's expectations, and on the evidence we can present. In light of this, the advisory board can expect a revised statement of outstanding universal value that will update the report it accepted in January 2009.

A third draft of the comparative analysis is being prepared. It is still a challenge, but in light of the progress made with the international experts, the direction taken by the comparative analysis is stronger and will hopefully meet expectations in the very near future.

<u>Next steps:</u> <u>Complete revised statement of outstanding universal value and draft 3 of the comparative analysis.</u>

#### **Evaluation of present state of conservation:**

The revised statement of outstanding universal value includes statements on integrity and authenticity. Section being drafted.

Next steps: Compile recent data from Department of Agriculture on dykes and aboiteaux. Draft statement of integrity and authenticity.

# Assessment of factors affecting the property:

Coastal erosion report finalized with the assistance of the Ecology Action Centre.

Next steps: Include in the draft nomination proposal.

# Monitoring plan:

Condition indicators were developed and included in the management plan. An outline of monitoring process is being prepared.

Next steps: Finalize draft monitoring process.

#### Develop protective and management system for the proposal:

National historic site process

Aboriginal consultation complete.

Next steps: Final draft being prepared for internal approval and delivery to Minister's office.

Municipal process (see planner's report)

The Community Plan Liaison Committee and municipal planners are preparing for consultation with the community.

Next steps: Review by the Liaison committee.

#### Management plan

A second meeting took place between archaeologists in early February to review the first draft on the archaeological heritage strategy. A second draft was prepared and has been circulated in jurisdictions for comments and review. Comments are expected back on March 12<sup>th</sup> to prepare a third draft.

A first draft of a risk preparedness plan is ready for discussion. It outlines the threats from natural disasters, describe the way they may affect the cultural heritage that support the World Heritage proposal, and explain the response strategy from authorities. Discussions with the municipality of the county of Kings' emergency measures officer will need to occur.

The management plan working group is expected to meet again on April 30<sup>th</sup>.

Governance structure discussions underway. Meeting with provincial ministers was positive. A list of specific asks has been prepared and will be forwarded to the provincial authorities for consideration. A meeting with Parks Canada is scheduled for mid-March.

Next steps: Complete third draft of archaeological heritage strategy. Review draft of risk preparedness with emergency measures specialists. Prepare third draft management plan.

# Visitor and Interpretation:

Work completed.

Next steps: Include information in nomination proposal.

# Draft proposal:

Sections 1 and 8 completed. Appendices compilation underway. Map production underway. Section 2, 3, 4, 5, 6, and 7 underway.

Next steps: Draft sections of the nomination proposal.

### Project administration:

See financial report.

Next steps: See financial report

#### Communication and public engagement:

The symposium held at Acadia University on April 17<sup>th</sup> was a success. The different speakers were engaging and conveyed useful information about agricultural heritage. They demonstrated the complexity of managing that form of heritage and its importance from a global perspective. There was good attendance. The partnership with Acadia University was very successful and we are thankful for their support in organizing that event.

The community event was also very successful. Dozens of volunteers contributed time and resources to make this a very well attended event with close to 150 people for the entire afternoon. Over a dozen exhibitors contributed everything from food, to pictures, to antique tractors, to agricultural implements, art, and unique artefacts to the day. Two local farmers shared stories of life on the marsh and answered questions from the crowd. We are thankful for the many volunteers and exhibitors who contributed to this very successful International Monuments and Sites Day. Next year's theme will probably be around Heritage of Water. The event was well

covered by the media. Crews from Global TV, Eastlink, Radio Canada, and CTV were on site covering the event.

An update is expected to be provided to the community on the project's progress sometime before end of June.

Next steps: Organise community update meeting.

Engagement of the Acadian community

Members of the Acadian community approached Nomination Grand Pré to try to organize an event to engage youth. Further discussions will take place in the coming months.

Next steps: Continue discussions with community leaders for presentations and activities.

Engagement of the Mi'kmaq

As we are continuing our work on the process, including developing a governance approach, it is essential to actively engage the Mi'kmaq. Chief Clark has continued to indicate support for this initiative on behalf of Glooscap community.

Next steps: Meet with Chief Clark and other Mi'kmaq representatives to discuss future of the site and nomination proposal.

### Economic development & interpretation strategy:

Complete. See Tourism Strategy report from consultants.

Next steps: None

#### Approval process for final document:

The Canadian delegation to the World Heritage Committee reviews and signs the nomination proposal once it is ready to be sent. Initial review of the draft will take place in the months of July –August 2010.

There is still a need to clarify the provincial and municipal process in support of the nomination.

Next steps: Clarify with municipal and provincial authorities approval process.

Objet : Lettre d'appui de la Société Nationale de l'Acadie au projet de la reconnaissance

du paysage culturel de Grand-Pré comme site du patrimoine mondial de

l'UNESCO.

Au nom de la Fédération des francophones de Terre-Neuve et du Labrador, je suis heureux d'apporter un appui inconditionnel au projet de reconnaissance du paysage culturel de Grand-Pré comme site du patrimoine mondial de l'UNESCO. Grand-Pré, lieu de pèlerinage des Acadiens et centre mondial de la commémoration de leur Déportation, est le foyer historique le plus important du peuple acadien. Il illustre la période située entre la colonisation acadienne de 1682 et les déportations qui se sont produites à partir de 1755. Il évoque aussi les heures les plus douloureuses et les plus héroïques des Acadiens, et il rappellera aux générations futures l'exemple d'un peuple d'un courage hors du commun.

Ce « grand dérangement » a fortement influencé l'histoire des Acadiens, mais, en retour, il a renforcé sa fierté de peuple et enrichi, de façon légendaire, son patrimoine. Ce lieu commémore également le profond attachement qu'éprouvent les Acadiens de partout dans le monde envers cette région, cœur de leur patrie ancestrale et symbole des liens qui les unissent.

Les Acadiens ont forgé à la sueur de leur front un paysage culturel unique qui a survécu jusqu'à aujourd'hui comme témoignage de leur ingéniosité, de leur détermination et de leur courage. La valeur unique de Grand-Pré réside dans sa signification historique, politique, morale, pédagogique, sentimentale, économique et culturelle. Il existe très peu d'endroits qui combinent un apport distinct dans tous ces domaines. Grand-Pré représente tout d'abord l'histoire de la colonisation et de la lutte pour le pouvoir et la richesse. Avec ses digues, le paysage incarne l'industrie des Acadiens qui ont su créer un système très efficace d'agriculture. La contribution pédagogique de l'endroit s'agrandit quand l'on compare les digues de Grand-Pré avec les digues de la Louisiane. On peut penser au livre de Jared Diamond, Collapse, dans lequel il attribue les succès et les défaits des régions à leur capacité. 

# **Background**

The following email from Naomi Blanchard in April 2010:

Peter and Gerald:

As Bob Martel and I have discussed with you and as was presented to Nomination Grand Pre some time ago, there is much interest in the Grand Pre community in acquiring the above property, currently for sale, as a View plane location. To that end, we are now seeking to formalize this interest and ensure that is a unanimously-held desire in the community.

We are asking all the organizations in the community to consider the desirability of this initiative and to pass a resolution to endorse an ad hoc formal community committee with the sole purpose of realizing the acquisition and implementation of a Viewplane site.

We understand there is a Nomination Grand Pre meeting in early May. We would like Nomination Grand Pre to endorse formally this initiative. The scope of the initiative can be presented at the meeting (if you should deem this necessary - 10 minutes should be enough time.)

If the concept is unanimously supported by all GP organizations, then following a community discussion and consensus - targeted for May 26th - a volunteer for the committee - a representative from each community group - would be requested.

If there is not consensus from the entire community, the initiative will NOT be further pursued.

I look forward to your confirmation that this matter can be considered at your May meeting.

# Consideration of the issue:

The Steering Committee reviewed this request. The following past notes about this issue were considered.

# 1. Notes from Sept 2008:

Motion: The Steering Committee will discuss the property acquisition value. Any useful information regarding this should be sent to Erin, Naomi's presentation will be sent to Louise and Claude will send previous site selection process to Erin.

# 2. Notes from Feb 2009 meeting:

Recommendation: Proposed Acquisition of Trenholm Property:

The steering committee struggled with how this recommendation would fit in with the project. They recommended a second parallel group to work as a funding initiative. There should also be more studies done on this issue which maybe could be part of next summer's interpretation study.

The Steering Committee reviewed the March tourism report. This report suggests that the newly acquired Parks Canada land up to Old Post Road will provide a great area for a viewing deck. The Advisory Board authorized the Steering Committee to move forward with this Legacy Project at the March 2010 meeting. This process has begun.

The Steering Committee also notes that with less than nine months to go to dossier submission, the focus of the Steering Committee must continue to be the necessary elements for the dossier. In particular, the plan for the management of the site and MOU's with the various partners must be secured. Staff time needs to be focused on the essentials to maintain the focus on accomplishing the submission. Adding another issue has the potential to complicate the negotiations with the key management partners.

The four priorities for the project were firmly established at the January 2010 Advisory Board meeting as follows:

- 1. Maintain current levels of support;
- 2. Prepare the nomination proposal;
- 3. Secure commitments; and
- 4. Deliver on the legacy project.

# Recommendation

The Steering Committee suggests that the land acquired by Parks Canada in 2009 provides the opportunity for viewing the entire area proposed for World Heritage designation. This opportunity was identified as a priority by Hockin Cronin consultants to provide visitors with a location to view and understand the Outstanding Universal Value. In light of this requirement being fulfilled, the decision from the Advisory Board in January 2010 was for Nomination Grand Pré to focus on four priorities to benefit the entire community and maintain the existing positive relationship with the funding partners.

Suggested recommendation: The Steering Committee recommends that a letter be sent on behalf of the Advisory Board to Ms. Blanchard wishing her success in her efforts but indicating that the project is unable to participate.
