#### GENERAL

#### Schedule and tasks

- The Outstanding Universal Value (OUV) working group held its second meeting on October 24<sup>th</sup> at Acadia University. Its third and final meeting is scheduled for November 28<sup>th</sup> also to be held at Acadia University.
- The development by ICON Communications of the communication and public engagement strategy is underway. It is scheduled to be ready by November.
- The planning process for the national historic site has experienced delays. The planning process for the community has stimulated a high level of interest that requires more time to engage. The target dates of completion have been revised.
- Archaeological work is underway in the dykelands. The second phase of coring managed to extract a few samples before an unexpected damage to the coring machine delayed the work. Expected completion date is currently delayed by a number of weeks.
- The request for financial support to implement the Acadian community engagement has been reviewed. It is expected to be sent in time for consideration in the next fiscal year. Start date for the implementation of the Acadian engagement strategy is targeted for July 2009.
- The budget is expected to be finalized in the near future following the announcement in early November of the funding approval by ACOA.

#### Finance and resources

Funding from ACOA been confirmed.

Forecasted expenditures end of calendar year include the development of the communication and public engagement strategies, an archaeological survey of the dykelands, and support for the OUV working group's work (including an additional meeting).

#### Retreat

On October 20<sup>th</sup>, members of the Steering Committee met on a retreat at a camping resort near Kejimkujik National Park. The objective of the retreat was to review the accomplishments of the past year, the schedule, the budget, and discuss the next steps. The retreat was an opportunity to take the time to have a critical discussion of all aspects concerning project operations, challenges in the process, untapped opportunities, and to propose concrete measures to adjust the course.

The outcomes of that retreat were a revised timeline, modified budget items, and improved protocols for internal communication and distribution of information. The memos to the Advisory Board on the budget and on the schedule provide further details and recommendations for consideration by the Advisory Board.

#### **Justification for Inscription:**

The OUV working group has had a number of discussions in smaller groups to address specific issues raised at the September 12<sup>th</sup> meeting. Meetings were held with, amongst other, Jonathan Fowler, John Reid, Phyllis LeBlanc, Daniel Paul, Gerald Gloade, and Sherman Bleakney to refine the archaeological, historical, Mi'kmaq, Acadian, and natural understanding of the area. In addition, a presentation was made to the *Comité consultatif acadien* (Acadian advisory committee), a Parks Canada committee that includes representatives of the key Acadian organisations in the Maritimes, to discuss the Acadian dimension of the site. Finally, the issues raised at the September 12<sup>th</sup> meeting were forwarded to the members of the Canadian delegation (Parks Canada in Ottawa) to seek guidance based on their experience with dealing with them.

The OUV working group held its second meeting on October 24<sup>th</sup>. Hereunder is John Johnston's (chair) report, sent by email to the project manager on October 30<sup>th</sup>.

### **OUV Working Group**

We had our second meeting on October 24 at the Irving Centre on the campus of Acadia University. Dr. Stephen Henderson of our Working Group made the arrangements for the room and Marianne Gates of Kings CED looked after the other logistics. Attendance was not as good as it had been at the first meeting (back on September 12), but that was because of other commitments for members and not any lack of enthusiasm on their part for the work of the committee. Translation services were not available this time, but arrangements have already been made for the interpreter to be with us at what is expected to be our final meeting, either November 28 or December 5. As of right now, it looks as if that meeting will be held on November

28. It too will be held at Acadia University, but in a different room that will better accommodate the large attendance and which will offer better acoustics than we had on October 24.

The second meeting achieved its objectives of (i) exploring the basic elements that will need to be communicated when the OUV is articulated; (ii) identifying the attributes associated with those messages in terms of integrity and authenticity; and (iii) identifying the UNESCO criteria which seemed to offer the best fit for the elements identified. Those criteria were iii, v and vi. We did not have sufficient time to make firm recommendations on the area(s) that should be included within the boundaries of a projected World Heritage Site. That will be addressed at the next meeting, at which time we will also -- it is expected -- come to a consensus on a Statement of Outstanding Universal Value and confirm the applicability of the criteria tentatively selected on October 24.

Between now and the third meeting, the Parks Canada staff working with the Working Group will be meeting with experts on the history of the Mi'kmaq, the Acadians and the Planters to confirm the focus and story-lines being emphasized. Several such meetings have already been held --sometimes with small groups of Working Group members and sometimes with other experts. Those smaller meetings along with exchanges of emails have been extremely helpful. A consensus among Working Group members seems to be developing on how best to frame the argument for Group Pré to be considered as a candidate for a World Heritage designation.

Two of the Parks staff, Ronnie-Gilles LeBlanc and John Johnston, will be communicating some of their research findings with the local community on Nov. 5, at 7 pm, at the Horton Community Centre. This will be a public presentation and the focus will be on the evolution of the landscape as revealed through maps, photos and documents. While the presenters are not going to be speaking about the UNESCO project per se there is of course a possibility that questions on that topic might arise during the question period. If so, neither speaker will speculate about any possible boundaries but will confine themselves to the elements that they and the Working Group have so far identified as being of possible World Heritage significance.

The archaeological survey of the dykelands is being carried out by Katie Cottreau-Robins (provincial archaeologist), Rob Ferguson (Parks Canada archaeologist), and Dave Scott, professor at the department of Earth Sciences (Dalhousie University). The survey is possible because of the support of the landowners who accommodated the team in allowing it access to key areas of the dykelands. The second phase of the survey, consisting of the coring of target areas of interest, began in early October. Unfortunately, the coring machine broke down after only a few core samples were taken. The coring is expected to resume early November, once the machine is repaired. This has introduced a delay and required a scaled down coring strategy. Cores will be taken from two areas instead of the three originally considered and fewer samples will be extracted. The archaeologists suggest that it will not significantly impact the results. It will, however, have an impact on the target date to get the the results of the survey back. It is not expected to require additional funds to complete the project.

Next steps: small groups of members of the OUV working group have separate discussions on the criteria, the justification, and the boundary proposed at the October 24<sup>th</sup> meeting. A teleconference is scheduled with the Canadian delegation to discuss the outcome of the October 24<sup>th</sup> meeting and confirm the viability of these outcomes and seek guidance for the next steps. A third and expected final meeting of the OUV working group is scheduled for November 28<sup>th</sup>. A community presentation on the latest research results by the John Johnston and Ronnie-Gilles LeBlanc is scheduled for November 5<sup>th</sup>. The archaeologists will return in the field in November for to continue the second phase of the survey.

The planning process for the national historic site is underway. The process is going slower than expected, due to changes in internal policy on planning procedures. The penultimate draft of the scoping document is completed and should be ready for review by the field unit superintendent in November for submission to the CEO in November. Once the scoping document is approved, the public engagement phase can begin to draft a management plan that builds on the previous plan.

Next steps: complete the scoping document and seek CEO approval.
